Grant schemes

War Memorials Trust administers grant schemes for the repair and conservation of war memorials in the UK. Most types of war memorials are covered and all works funded need to follow best conservation practice.

To find out if your war memorial project could get a grant you need to fill in a Grants Pre-application form. A member of the Conservation Team will review the type of memorial, the proposed works and costs. If your project is eligible we will send you an Application Form. Please note that projects cannot be funded if they have already started or have finished.

Dear Supporters

In July, Peter McCormick stepped down as Chairman of the Board. He was one of the charity's earliest Trustees, taking on the role of Chairman in 2013. Trustees, staff and all involved with the charity would like to extend their thanks to Peter for his dedicated service and wish him the best for the future.

Stepping into the role of Chairman is Rupert de Mauley. A Trustee since 2017, Rupert is a chartered accountant and former investment banker who has been a Member of the House of Lords since 2005. He was an army reservist for thirty years, is Honorary Colonel of the Royal Gloucestershire Hussars and Chairman of the Council of the Reserve Forces and Cadets Association. We look forward to continuing to deliver our work under his leadership.

Public Engagement - Can you help?

Can you help? requests


Regular readers of the Bulletin will be familiar with our 'Can you help? requests.' These are war memorial cases the Trust needs help with. They are either part of our current casework or previous grant awards. We need volunteers to visit the memorials for us, to take photos and check their condition so we can then act if there are any concerns.

There are currently over **300 requests** across the UK on War Memorials Online.


For those who have not used the website yet, or perhaps are not confident about what to do, this article aims to provide some guidance. We are also happy to talk through any issues if that would be helpful. Contact us using the details at the foot of page 9 to arrange a meeting or telephone call.

Find cases near you

1. Go to www.warmemorialsonline.org.uk and head to the Memorials page. This can be found by clicking on the word MEMORIALS in white on a blue background at the top of the page. It is highlighted by the yellow arrow in the image below.



2. In the red 'Find or submit a war memorial' section of the page there are two ways to search. The 'KEYWORD SEARCH' enables you to search by specific words. The 'LOCATION SEARCH' helps you find those in a specific area. Often location search is better to find 'Can you help? requests'. This search page is shown at the top of the next column with arrows indicating the sections explained in the following points.



- 3. Click on the words 'LOCATION SEARCH' in black on the grey background
- 4. Start by entering your postcode in the white text box which says 'Search the memorials by location'. Next to that it says 'Within 1 mile'. You can click on the 'v' symbol to change the size of the search area depending on how far you would be willing to travel. Do not press search yet.
- 5. Below the white box there is a '+ FILTER RESULTS' section. Click on the '+' symbol. This provides more ways to manage your search. In the section called 'CONDITION', click in the white box next to 'Can you help?'. This should turn it blue with a white tick.
- 6. Now, click on the yellow button 'FILTER RESULTS'. The next page will show a map. At the top there is a 'MAP VIEW' option underneath it will say how many results there are e.g. 1-20 of 20 results. If it says 0 of 0 this means there are no cases in the area you selected. You may need to increase the number of miles you are searching to see cases. You can also view the search results by clicking on the 'LIST VIEW' option which will list them with a small picture of each one.
- 7. To open the specific page for each war memorial from the map, click on the yellow pin with the ? on it, then click on the name of the war memorial which should be underlined in blue. That should open a new page with information about that war memorial. From the List view, click on the name of the war memorial to open its page.

Public Engagement - Can you help?

Look up specific cases

Often in the Bulletin we will list specific cases we need help with. We provide a number for each one e.g. WMO/256855. If you have this number you can search more directly by entering the number e.g. 256855 into the 'KEYWORD SEARCH'.

Some war memorials for which an up-to-date condition survey would be helpful are:

- 1. St Mary's Church in **Bolsterstone**, South Yorkshire received £260 in 2018 (WMO/159659)
- 2. Brunner Mond & Co Works on Brooks Lane in **Middlewich**, Cheshire received a grant of £790 in 2019 (WMO/256855)
- 3. **Myddfai** WW1 tablet at St Michael's Church in Myddfai, Carmarthenshire looks to be in Poor condition from an undated photo. Current photos will help determine if action is required (WMO/268978)
- 4. St Mary the Virgin Church in **Smeeth**, Kent received £590 in 2018 (WMO/153576)
- 5. St Mary the Virgin Church in **Warmington**, Northants received a grant of £1,920 in 2018 (WMO/108918)

What you can do


On the individual page for each war memorial there is a section called 'Can you help?'. This has details of the information being requested and why. Once you have registered as a user, you can add your photos and condition updates directly to the relevant war memorial record. This enables our Conservation Team to review and take any action required. This may include contacting the memorial's custodian to offer our advice. Alternatively you can contact the Conservation Team directly, see below right.

There is also a Frequently Asked Questions page at www.warmemorialsonline.org.uk/faq if you have more queries. We can also post or email helpsheets on registering, assessing condition etc.

WMT Grants Scheme - Glasgow Methodist Churches

Claremont Street Methodist Church war memorial plaque was moved to Partick Methodists when Claremont Street closed in the 1950s (<u>WMO/263954</u>). It moved again in 2024, alongside the Partick war memorial (<u>WMO/263951</u>), when Partick Methodists relocated to Woodlands Methodist Church in Glasgow.

Claremont Street is a bronze plaque, on a dark marble mount, with black lettering dedicating it to the 21 men of the congregation killed in World War I. Commemorating the 29 members of Partick Methodists who gave their lives in the same conflict, is a white marble plaque mounted on black marble. It has an incised central inscription panel flanked by paired Doric columns, surmounted by a round arch headed moulding over a carved Maltese Cross.



In 2024, £3,200 from War Memorials Trust Grants Scheme, supported by **Historic Environment Scotland**, assisted the works to relocate both memorials. They were dismantled using diamond cutting wire, along with appropriate diamond blades, which cut through each bedding joint to facilitate removal. At the new site, the memorials were reassembled using colour matched epoxy resin fixing them to the wall and each individual piece to the next, inserting new dowels or ties as required. Stainless steel plates were inserted on the underside to support the weight of the memorial and fix it in place. SmartWater was also applied to help deter theft as part of the In Memoriam 2014 initiative.

Claremont Street memorial includes the name of Walter Daniel John Tull, listed alongside his contemporaries in alphabetical order. Walter was born on 28th April 1888 in Folkestone to a father from Barbados and a mother from Kent. He started playing professional football in 1908 and was the second person of African-Caribbean mixed heritage to play in the English Football League's top division and the first of African descent to play for Rangers when stationed in Scotland. He joined the 17th (1st Football) Batt of the Middlesex Regt as a Lance-Corporal at the start of World War I. He suffered shell shock after service in France but was back in action in 1916 and participated in the Battle of the Somme. Following officer training he served in the 23rd (2nd Footballers) Batt of the Middlesex Regt as a 2nd Lieutenant. Tull is believed to be the first African-Caribbean mixed heritage man to lead white troops into battle for the British Army. When promoted in 1917, army rules technically forbade a 'person of colour' being commissioned as an Officer. He died on 25th March 1918, aged 29, during the Second Battle of the Somme and is commemorated at the Arras Memorial to the Missing.

WMT Grants Scheme - Clocks

St Mary the Virgin WWI Clock, East Chinnock, Somerset

Fitted to the north and west faces of St Mary the Virgin Church tower is the war memorial clock dedicated to the 12 local men of the parish killed in World War I (WMO/132089). The clock is powered by two weights, each one approximately 125kg. These would originally have been wound weekly by hand from ground level to 37 feet high. There is an associated white marble tablet within the church carrying the names of the fallen. St Mary's is located on the High Street in East Chinnock and is Grade II listed.

In 2024, a grant of £1,850 was awarded from War Memorials Trust Grants Scheme, supported by voluntary donations. Over time the motion that moved the hands of the clock had seized up. This was removed, repaired and reinstated in 2025 so the clock can again perform its commemorative function. SmartWater was also applied to help deter theft as part of the In Memoriam 2014 initiative.

In 1919, the voluntary subscriptions collected in the parish had covered the cost of the clock at £160 and the plaque at £20.

St Nicolas' Church, Baydon, Wiltshire

Baydon war memorial clock is installed into the church tower of St Nicholas' Church in the village of Baydon (<u>WMO/242049</u>). There is a single external face comprising a black dial with gold coloured time intervals, hour and minute hands. The clock is dedicated to those who died in World War I and World War II with associated plaques in the church for each conflict. Both plaques have the first letter of principal words infilled with red paint whilst the remaining text and numerals are infilled with black.

In 2023, £5,210 was awarded from War Memorials Trust Grants Scheme, supported by voluntary contributions, towards repair works which completed in 2025. The clock was removed to a workshop environment for specialist repair to return it to working order. Alongside mechanical works, the dials and numbers of the clock faces were refurbished and re-gilded to reinstate the original design. SmartWater was also applied to help deter theft as part of the In Memoriam 2014 initiative.

The memorial was dedicated on 6th August 1919.

Grants for War Memorials and WMT Grant Scheme -

Two very different war memorials in Tyne and Wear have recently received grants.

The Tynemouth South African war memorial is located on the village green on Front Street in Tynemouth (WMO/106200). The red sandstone pillar has a two-stepped base, upon which stands a plinth with decorative pillars at each corner. It is surmounted by a short, broad and slightly stepped column with four decorative buttresses and a metal domed cap. Bronze plaques on the south and west faces commemorate Men of Tynemouth who died in South Africa 1899-1903. Those are the dates on the memorial although now the conflict is more often perceived as 1899-1902. The memorial is Grade II listed and within Tynemouth Village conservation area.

In 2024, £15,800 from Grants for War Memorials scheme supported by **Historic England** assisted conservation works. The bronze plaques were carefully cleaned and a protective microcrystalline wax was applied to the surface. Stonework was hand-cleaned with water using natural bristle brushes whilst joints were carefully raked-out by hand and re-pointed using a lime mortar.

The original surface of the red sedimentary sandstone had eroded over the years impacting some of the carved detailing and resulting in delamination of large surface areas. Delamination occurs when layers of stones begin to separate creating an inconsistent surface as sections fall off. Best conservation practice supports maximum retention of original fabric whist pragmatically reinstating the original design.

this instance. а combination approaches were used. Some areas were consolidated using lime mortar whilst in others damaged stone was replaced with Other architectural new stone indents. features, such as the finial balls, had been lost and these were reinstated based on archival evidence. This did not include a pinnacle that may have been atop the cap. Since no definitive evidence could be found. it was not deemed appropriate to guess and potentially alter the original design.

The second grant was awarded in North Shields. After World War I, the community chose to create a composite war memorial, one made up of different elements. One part was a three-storey, brick built extension to the Victoria Jubilee Infirmary Hospital (now Tynemouth Royal Infirmary) which had a stone plaque in the entrance hall featuring a relief carving of a physician holding children's hands. It is understood the extension was demolished in 1999-2000.

Another aspect is a semi-circular stone memorial outside the hospital, opposite the site of the extension (WMO/112083). The cenotaph, wall, piers and seating are built of Portland stone and incorporate a bronze plaque with the relief carving of an angel with uniformed men. The inscription references a book of honour stored in the public library. The site has square sandstone paving and granite steps. It is Grade II listed by Historic England but is not in a conservation area.

Therefore, in 2024, the grant of £1,250 came from War Memorials Trust Grants Scheme, supported by voluntary donations. Stonework and metal was cleaned using a DOFF steam system with a protective microcrystalline wax then applied to the plaques. A poultice was bronze used below the to reduce verdigris staining, although this can be rarely be removed entirely. Joints were carefully raked-out by hand and re-pointed using an appropriate lime mortar.

The surface of the stone carrying the lettering had eroded causing the original lead or black lime mortar filler to fall-out; the colour can be seen in the historic image. The initial proposal was to replace the lead or black lime to follow the original design. However, due to the deterioration of the stone there was concern that this would not hold. It was agreed to incise (cut) the lettering into the stone instead. Rubbings of the most welldefined existing lettering allowed stencils to be created to ensure the same font was used. The stone face was then lightly dressed back in a workshop. The inscription was then reinstated with style and spacing matching the original.

The projects were undertaken together by experienced stone conservators overseen by a conservation-accredited professional advisor. The project required careful consideration to ensure that a balance was struck which protected the inherent heritage value of the fabric whilst allowing the memorial to continue its commemorative function. Good communication was required by all parties to identify appropriate solutions based on best conservation practice and clear evidence.


